

## Terms and conditions for Approved Garages Las Vegas Competition 2019

- 1. These terms and conditions ("the Terms") are the terms and conditions that apply to the "Approved Garages Darts in Las Vegas competition" ("the Promotions") as promoted by Group Auto Union UK & Ireland Limited (company number 1416163), owner of the Approved Garages concept whose registered office is at Roydsdale House, Roydsdale Way, Bradford BD4 6SE ("the Promoter").
- 2. Eligibility Win a trip to Las Vegas Darts (the "Competition" or "Prize Draw") is only open to legal residents of the United Kingdom, who are eighteen (18) years of age or older. The Promotion is not open to residents of the Republic of Ireland, Northern Ireland or the Isle of Man. Persons in any of the following categories are NOT eligible to win a prize: (a) directors, members, partners, employees, consultants or agents of Sponsor or Administrator and their respective affiliates, and each of their respective companies, subsidiaries, advertising and promotion agencies, (b) suppliers of goods or services in connection with the Competition, including individuals engaged in the development, production or distribution of materials for the Competition; and (c) persons who (i) are in the immediate family of any person in any of the preceding categories (including mother, father, sister, brother, daughter, son, spouse, grandmother, grandfather, children or grandchildren), regardless of where they live, or (ii) reside in the same household, whether related or not, as any person in any of the preceding categories. All eligibility is subject to all national, provincial, municipal, territorial and local laws and regulations. - 3. **Participation** in either of the Promotions constitutes acceptance of the Terms. By entering any of the Promotions all entrants will be deemed to be bound by the Terms.
- 4. **Competition.** The Competition begins on Thursday, February 7, 2019 at 7.00pm Time in Greenwich London ("GMT"), and ends on Tuesday, May 17<sup>th</sup> 2019 at 23:00:00 p.m. GMT (the "Entry Period"). There will be one (1) unique random drawing to award one (1) prize. Entry in the Competition does not constitute entry into any other promotion, contest, or Competition. By participating in the Competition, each Entrant unconditionally accepts and agrees to comply with and abide by these rules, the Official Rules and the decisions of the Sponsor, and/or the Administrator whose decisions shall be final and legally binding in all respects and not subject to further review in any forum.
- 5. **In the event of any dispute** regarding the conduct of the Promotion and all matters relating to the Promotion, the decision of the Promoter is final and binding and no correspondence or discussions will be entered.
- 6. **No entries from agents**, third parties, organised groups or entries automatically generated by computer will be accepted.



- 7. How to enter. To enter: No purchase necessary. There are two (2) ways to enter:
  - (a) Enter using our Facebook Sponsored post form or visit <a href="www.approvedgarages.co.uk">www.approvedgarages.co.uk</a> and enter using the form on the website. You will be directed to promo.approvedgarages.co.uk where you can submit your details by visiting our homepage and scroll down to find our competition on the Approved Garages' website during the Entry Period and you will be entered in to the Competition.
- 8. **Limit.** You may enter one (1) time per email address during the Entry Period, no matter which form of entry you select. Entries more than any stated limitation, and entries generated by script, macro or other automated means, or any means that subverts the entry process, will be <u>void</u>. Sponsor will determine, in its sole discretion, what constitutes a valid entry, and reserves the right to reject any submissions that it deems, in its sole discretion, to violate any of Sponsor's policies, standards, or practices. All materials and entries submitted become the property of the Sponsor and will not be returned or acknowledged.
- 9. **Opt in options** When registering to enter the Promotion, entrants can opt in to receive marketing material from the Promoter. In doing so the entrant consents to their registration details being added to the Promoter's mailing list and they may receive newsletters and MOT reminders from the Promoter via email. Potential winners will be notified by e-mail, or telephone using the contact information provided by the potential winner at the time of entry. Sponsor shall have no liability for any notification that is lost, intercepted, or not received for any reason. If, despite reasonable efforts, any potential winner does not respond with requested information and documentation [see section 12] within two (2) days of the first notification attempt, or if prize notification is returned as unclaimed or undeliverable, such potential winner will forfeit the prize, and at Sponsor's discretion, an alternate potential winner may be selected. - 20. Personal data provided by entrants will only be used in accordance with the Data Protection Act 1998 ("the Act")
- 21. Subject to clause 25, if the Promoter fails to comply with the Terms, the Promoter shall only be liable to the entrant for any losses that she or he suffers as a result of the Promoter's failure to comply (whether arising in contract, tort (including negligence), breach of statutory duty or otherwise) which are a foreseeable consequence of such failure.
- 22. Subject to 25, the Promoter will not be liable for losses that result from the Promoter's failure to comply with the Terms that fall into the following categories: (a) loss of income or revenue; (b) loss of business; (c) loss of profits; (d) loss of anticipated savings; (e) loss of data; or (f) waste of management or office time.
- 23. Nothing in the Terms excludes or limits in any way the Promoter's liability for death or personal injury caused by its negligence or the Promoter's liability for fraud or fraudulent misrepresentation.
